**THE RNZAC HISTORY PROJECT - 2019 TO 2023-UPDATE**

**Author Matters**

Matthew Wright has just completed his first year as our Author. He developed his Work Plan this year so that research and writing could be done in parallel starting with “green fields” aspects. This approach has allowed time to be available to him for managing challenges as the project proceeds.

This first year has involved Matthew in project planning, preparing the bulk of the appendices (substantial scale, rigour, with prescribed content) and some general research. Matthew will proceed over the next two years to research and write the main text, starting with the 1947-2020 period.

Matthew has good background on the earlier periods, but will need to conduct detailed research on aspects associated with mounted units and the Corps. Having that background makes it possible to achieve the expected scale of text in the time frame, which is equivalent to about three books of ‘ordinary’ length, on top of the appendices.

Within the regime described above, Matthew has completed the Vehicle Appendix which has been checked by Jeffrey Plowman (who is also very kindly providing photos of each vehicle for this Appendix and others for the History for our consideration)

Matthew is also well advanced on producing the Rolls of Honour up to 2012. I have agreed to initially develop the Draft Memorial Roll (1947-2020). Colonel (Retired) Trevor McComish (Colonel Commandant RNZAC) and Ian Bolton (fellow Trustee) have provided valuable assistance in this area. I hope to have this Roll completed this month.

The Honours and Awards Appendix is also well advanced but again I have agreed to initially draft the Table for the period 1947-2020 because of the difficulty of locating reliable data for this era. I am being assisted in this by David Baguley (whom some of you may remember from earlier days of the Corps). David managed the New Zealand Honours System for a number of years and I am grateful for his assistance. Jack Hayes (previously RNZIR and NZSAS) is also helping with this task. Lt Col Glenn King (Regimental Colonel RNZAC) has also offered to assist David Baguley in this as Point of Contact for the Corps. We are also adding a Non-Service Awards Section to this Appendix in recognition of special awards that



have been made by the civil sector to some serving members whilst they were in the RNZAC.

Matthew Wright is presently proceeding with the Unit Lists and Histories Appendix as well as the Regimental Property Appendix. Matthew's aim is to eventually link all these Appendices within a single "Appendices." All these documents will have some gaps but these can be back-filled during the project as more information becomes available during the project.

Matthew has also provided valuable assistance and advice during the publishing appraisal process, as has Christopher Pugsley, our Historical Advisor.

### **Publishing**

A publishing proposal was sent to our preferred publisher on 13 Oct 20. That publisher subsequently accepted the Trust's strict criteria regarding the History and consequently (upon request by the Trust) sent a Formal Proposal for evaluation by the Trust on 4 Nov 20.

At a Trust Board Meeting on 11 Nov 20, Trustees agreed on a list of points that needed to be negotiated with the publisher. These negotiation points were further refined on 25 Nov 20 at a Zoom meeting (attended by Chris Wotton and I from the Trust as well as Matthew Wright and Christopher Pugsley) on 25 November to evaluate and refine these negotiation points.

I am meeting with the publisher on 4 December to discuss these points with a view to achieving a mutually beneficial way ahead.

### **Assistance to the Trust**

Marc Parson's fundraising initiative to support the RNZAC HPCT with the donation of the profits from the sale of badged and logoed brew mugs has resulted thus far in \$250.00 being donated to the Trust. MTA's efforts to sell some of these mugs at Cambrai Commemorations at Waiouru 20-22 Nov 20 contributed to this overall total being realised. The Trust is grateful to Marc and to the MTA for their efforts.

I continue to go through 24 separate containers of documents, booklets, letters, maps, and photos that QAMR and Combat School very kindly gathered and delivered to me in July this year. So far, 591 pages of documents from the QAMR and Combat School consignment have been sent to the Author. In addition, 130 documents from individual contributors have been sent to the Author.

## **Funding**

### ***General***

There are many New Zealanders who continue to suffer from the economic and social effects of Covid 19. Understandably, donors are favouring Charities that support humanitarian assistance. The Trust recognizes this and accepts that our fundraising will continue to be a challenge.

We have reduced our overall budget and continue to review the way we do things to keep costs down. All our meetings are conducted via Zoom. This will continue unless it is necessary to do otherwise.

We remain committed to exploring all possible options for gathering funds including personal approaches and applications to Grants Boards, Foundations, Trusts and Corporates.

Given the Covid-19 recovery environment that we are in, the timing of the launch of any option is critical and we constantly reassess this. In this regard, Chris Wotton and Francie Russell, QSM, JP are conducting another funding review in January/February next year.

### ***Author's Fees and Expenses***

We allocate funds received from Corporate sponsors and Trusts to the Author's research and writing fees and expenses to ensure his continuity in the project. Our Fundraising Team of Christopher Wotton and Francie Russell continue to work hard to bring more funding in. Our Author, Matthew Wright has also been assisting in this regard.



### ***Breaking News***

I am very pleased to advise that we have just received a grant from the Lotteries Environmental Heritage Committee (LEH) of the Lotteries Commission. It is the second largest grant that has been made to the project. This great news has been hard won through the efforts of Chris Wotton, Francie Russell and Alan Day over the many weeks that it took to establish required working relationships with appropriate advisors and lodge the application. This grant means that, at this stage, we have sufficient funding for the Author to continue his research and writing through to the first quarter of 2022.

### ***The Trust's Expenses***

I want to thank those Serving Members of the RNZAC and those who have served in the RNZAC in the past who have donated funds to this Project since my last Update. We are grateful for your generosity.

I also want to especially acknowledge the fundraising efforts of the MTA Committee and those individuals who spontaneously made donations to the Project during the Cambrai Commemorations at Waiouru period 20-22 Nov 20. A total of \$1407.70 was raised. A great and generous effort by all concerned. Thank you.
